

What is *Extra*Care Housing?

Many older people considering residential care dread the prospect, not wanting to leave their own home and fearing a loss of dignity and independence. *Extra*Care Housing is a real alternative. It gives older people a fully self-contained apartment, with nearly all of the facilities and support of residential care available in the same building.

The Estate


- Josselyn's Court is a purpose built estate for frail older people. It provides self contained flats allowing residents to maintain their independence, dignity and personal choice.
- Set in pleasant landscaped gardens, Josselyn's Court consists of 27 *Extra*Care self contained flats and 8 sheltered flats in a modern two-storey building. Each property has a bedroom, lounge, a fully fitted kitchen, bathroom with level access baths/showers and a hall. Four flats are suitable for people using wheelchairs. Eight of the flats are allocated for 'ordinary' sheltered housing.
- All properties are linked to an intercom alarm system to provide 24 hour assistance in case of emergency.

Facilities

- Lift to upper floor.
- Residents Lounge, Dining Room, Common Room and Reading Room.
- A Guest Room for the use of friends and family.
- Laundry Room.
- 3 assisted bathrooms, 2 communal disabled toilets.
- Wheelchair battery charging room, Scooter Shed
- Medical Room.

The Services

An Estate Manager, employed by Hanover working on site.



- All flats are linked to a 24 hour alarm system, to respond to emergency situations and unforeseen needs, which are not catered for on care plans.
- Window cleaning and domestic cleaning services (to *Extra*Care flats only).
- Garden maintenance.
- Variety of regular visiting mobile shops.
- Regular Social Activities for those who wish to join in.

Rents and Service Charges

- Please contact us for up to date information on rents. We can also advise you whether you would be eligible for help with the rent from Housing Benefit.
- The rent for all properties is payable monthly by direct debit, standing order, or over the counter at any bank by using a bank giro credit system/swipe card.
- Service charges are included within the sum payable for rent. These charges cover the provision of landscaping, lighting to the communal areas and for administering the emergency call system.
- Residents are responsible for the payment of all their own bill accounts. These include: electricity, some water rates, council tax and home contents insurance etc.

Who can apply?

If you are:

- Aged 60 or over.
- Resident in the Bury St Edmunds District or have family living in the immediate area.
- Already receiving or needing to receive care (eg home care, meals, attending a Day Centre).
