If you want to remain independent and own your home, without the maintenance and safety worries of your current home, and with help available when you need it, consider MHA's retirement housing. Available for leasehold purchase, our properties are specially designed to meet the needs of older people now and into the future.



Abona Court is a purpose-built development of modern apartments on Shirehampton Road in Sea Mills, Bristol. The development forms part of the local community centre and shopping facilities are within a short walking distance. A post office, newsagent, and retail convenience store are all within the immediate area, and a bus stop is just outside.

Our apartments are arranged on three levels with a lift and wheelchair access throughout. There are 13 one-bedroom apartments and eight two-bedroom apartments, all of which are suitable for individuals or couples. The scheme is tastefully and comfortably decorated with many shared areas available at ground floor level including a residents' lounge/dining room, complete with kitchen, and conservatory, where residents can get together for a chat or social activities. Laundry facilities are available as is an office to accommodate the Manager. Gardens and parking for ten vehicles (including disabled access) are also available for your use.

Abona Court adjoins Sea Mills Methodist Church. Some apartments are built within part of the Church and include attractive features such as leaded windows. As part of the total development, there is the Church Hall, place of worship with separate meeting room, toilet and vestry, all contributing to a supportive and welcoming community. Residents can benefit from all services and activities on offer.



#### Manager Support

The part-time Manager is there to help you get the most out of living at Abona Court. The Manager is responsible for managing the day-to-day running of the scheme, including maintenance of the building and gardens as well as cleaning of the communal areas. The Manager is also available to support you personally, liaising with relevant health, social services or care agencies on your behalf to arrange care services, should this become necessary.

The light and spacious apartments comprise:

#### Safety and Security

Entrance to the building is through a communal front door which is kept locked for your security and peace of mind. Each apartment has its own door entry system with video phone which enables you to see who is calling and open the main door as you wish. For your safety, in the case of an emergency outside the Manager's working hours, there is a pull cord to access an alarm control centre that responds immediately to calls for help, 24 hours a day, 365 days of the year, and coordinates emergency services as required.

#### From the North

Leave the M5 at Junction 18, taking the B4054 signposted Shirehampton. At Sea Mills, the development is set back from the main road on the left between West and East Parades.

#### From the South-West

Leave the M5 at Junction 18 taking the B4054, signposted Shirehampton. Then directions as from the North.

#### From Bristol City Centre

Take the A4, Portway heading west towards Avonmouth. Turn right at Sylvan Way, A4162 and take second road on the right A4054, Shirehampton Road. The development is set back from the main road on the left between West and East Parades.
