The care home is situated in the Undercliff area of the Island and enjoys a year-round sub-tropical climate. It is close to many local attractions including the Botanic Gardens.

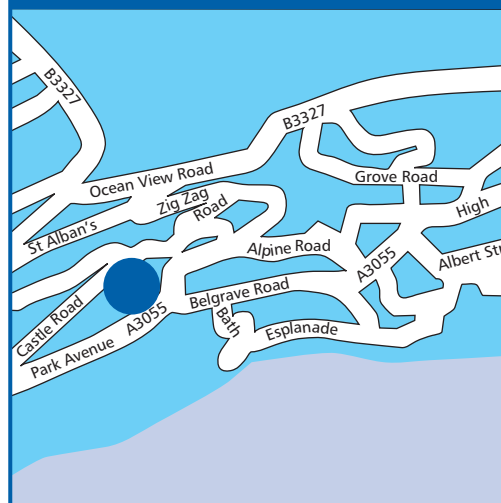
Extra care residents receive personal care and round-the-clock support from our friendly staff. Meals are cooked and prepared on site by professional cooks and residents benefit from a full laundry service. There is a day-care club, which is also open to the local community, and a busy programme of social activities for residents wanting to take part.

The care home gets regular visits from a hairdresser, chiropodist and district nurse.

Registered care for older people

At Byrnhill Grove in Ventnor, South Wight Housing Association provides self-contained registered care accommodation for 16 older people who need help with personal care. The home is registered with the Commission for Social Care Inspection.

Places can be offered to people who apply direct or who have been referred by one of our partner agencies, such as social services. All applicants undergo a full needs assessment before we make an offer.

In choosing to take up the offer, a resident enters into a contract with us, which they sign or which is signed on their behalf. Each resident has a plan which sets out the care and support they will receive while living at Byrnhill Grove.

Care home fees are not eligible for Housing Benefit. The fees for accommodation, care and support may be met by the resident or they may be met by social services, topped up by a third person or organisation.

We provide staff for 24 hours a day and seven days a week. Their job is to:

- provide full registered care support
- provide meals, laundry and personal care
- keep homes and the scheme clean
- help residents manage their finances, including claiming benefits and paying fees
- encourage residents to get involved in scheme and community activities
- involve other organisations that have resources to offer our residents.
