Offering care over three floors - the top level is believed to be unique in its apartment-style layout which gives residents almost unprecedented independence within a comforting cocoon - Methven House also enjoys a wide range of facilities ranging from in-house hairdressing to internet cafe facilities.

A state of the art sprinkler system, low surface-temperature radiators and other special safety and security systems have been designed-in, as have sun-pipes to provide natural light wherever possible, a direct-dial room telephone system with itemised billing, specialised bathing facilities, and an intercall alarm facility with its own audio link which alerts staff instantly to any problems and allows instant communication between residents and care staff.
