## YOUR DESCRIPTION

The accommodation at Milliner House comprises a 10 bedroom and an 11 bedroom house for older people with dementia, each with its own dining room and lounge. We also have a 10 bedroom house catering for younger people with dementia and a 9 bedroom house for dysfunctional older people. All rooms have en-suite facilities and all lounge areas have TV, DVD or video and music stations.

The care centre is set in attractive gardens 2 miles from Luton town centre. Junction 11 of the M1 is 5 minutes drive away and Leagrave railway station is half a mile away.
